

On 25 May 2018, Regulation 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation), hereinafter referred to as "the GDPR", came into force.

Due to the fact that your data are processed by GENERATIONS as part of the database of journalists which receive information about the actions organized by GENERATIONS (educational and entertainment actions addressed, among others, to children, youth, parents of teachers, kindergartens, schools), we would like to provide you with comprehensive information on the processing of your personal data, in accordance with the provisions of the GDPR.

GENERATIONS is the organizer of such events as: Festival Kinder+Sport Radość z Pływania, Rodzice i dzieci Powietrze bez śmieci, Być jak Ignacy, Body2Body.

Information on data processing

- I. The controller of your personal data is GENERATIONS sp. z o.o. sp.k., ul. Śmiała 31a, 01-523 Warsaw (hereinafter: "the Controller"). Your personal data are processed as part of the database of journalists which receive information about the actions organized by the Controller.
- II. The following categories of your personal data are processed: name, surname, workplace, position, contact details (e-mail, phone number, subject matter of the publications).
- III. Your personal data will be processed until you unsubscribe from the database of journalists. The Controller may also delete your personal data from the database if it is found that you are no longer engaged in journalistic activity (e.g. your data shall be removed from the imprint section of the web portal, newspaper or any other media entity).
- IV. Your personal data is made available to the controller's clients for whom the promotional campaign is organized and exclusively for the purposes of such campaigns. Clients are not entitled to use your data e.g. for their own marketing purposes.
- V. Your personal data was collected from public available sources (e.g. the Internet). The legal basis for processing your personal data is the legitimate interest of the controller (providing the media with information on educational and entertainment actions organized by the Controller) - Article 6(1)(f) of GDPR.
- VI. You are entitled to
 - information on the processing of the personal data (right of access) including the categories of personal data processed and the possible recipients of the personal data,
 - require incorrect personal data to be rectified or supplement incomplete personal data,
 - to require the deletion or restriction of the processing of the personal data, provided that the legal requirements for such a request are fulfilled,
 - submitting an objection - in the case of data processing based on the Controller's legitimate interest (Article 6 (1) (f) of the GDPR),
 - data portability - by receiving data from the Controller in a format that allows personal data to be transferred to a selected third party,
 - filing a complaint to the supervisory authority: Prezes Urzędu Ochrony Danych Osobowych, ul. Stawki 2, 00 - 193 Warszawa - where personal data are processed unlawfully.
- VII. Any requests, questions or demands related to the processing of personal data should be addressed to pr@gnrs.pl
